- KHA delivered reports may be replaced. Any report that you saved under a different name or created new will remain untouched. Replaced reports are available in Document History, if needed.
- Any KHA delivered report that you moved to a new location since the last upgrade will automatically move back to its original location.
- KHA product templates and calculation method libraries will be replaced.
- Product task panes will be replaced.
- Process definitions will not be replaced.
- Security roles and sub-systems will be reset to their configured settings. All user security exceptions you may have made will remain intact.
- Specific items configured as part of your company or organization's implementation such as imports, exports, driver files, and process management files, will remain as is. Any required modifications to these areas are covered in the release notes.

PFB-05557 - Entity.CM_DefaultDept column missing from update [TFS 13351]	<p>Symptom: The 2017.1 package update utility for Cost Management did not add the column CM_DefaultDept that is required for Cost Management.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05595 - CM Base PR Calculator saving zero value records [TFS 13845]	<p>Symptom: The CM Base Calculator utilities use SystemYear, but they need to use the year that matches the Cost Management file group.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05598 - CM Base PR Calculator Destination Table error [TFS 13724]	<p>Symptom: The CM Base Calculator utilities use SystemYear, but they need to use a year that matches the Cost Management file group.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05604 - CM Template EducationPlan formatting [TFS 13847]	<p>Symptom: In the EducationPlan tab of the CMMaster template:</p> <ol style="list-style-type: none"> 1. Change the total row in column R to Percent with one decimal. It is currently Percent with zero decimals. 2. Change the Total row in column S to Percent with one decimal. It is currently Percent with zero decimals. 3. Related to #2, change the calc method in column S to Percent with one decimal. The calc method currently displays NUMBER with zero decimals, so an entry of 5% shows as 0. 4. Change the Total row in column T has a Total line for Educ FTE Reduction to use the Number with 2 decimals formatting. It is currently Percent with zero decimals. <p>Explanation: Field fix is available. Resolution to be included in future release.</p>

PFB-05606 - CM Template AgencyPlan formatting [TFS 13817]	<p>Symptom: In the AgencyPlan tab of the CMMaster template, format the cells as percent with one decimal. In the CMMaster template, it is cells R45 and S45.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05608 - CM Template NonLaborSummary formatting [TFS 13819]	<p>Symptom: In the NonLaborSummary tab of the CMMaster template, column Q should be formatted as numeric with 0 decimals and comma.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05643 - CM plan file date formatting on LaborInitiatives tab [TFS 15174]	<p>Symptom: Column AA of the LaborInitiatives tab on the CMMaster template uses the Number format. It needs to be changed to use the Date format MM-YYYY.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05857 - Target Setting process [TFS 16722]	<p>Symptom: Create Financial Base and Create Payroll Base are not configured in the delivered system. Current steps are configured as a report.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05860 - Compute Org Statistics [TFS 16733]	<p>Symptom: Make cosmetic changes to the Instructions tab.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05868 - Missing Validation to CM_PlanCode: JobCode.JobCode [TFS 16735]	<p>Symptom: Missing Validation to CM_PlanCode: JobCode.JobCode.</p> <p>Explanation: Field fix: Edit table structure on the JobCode table. Add Validation to CM_PlanCode: JobCode.JobCode. Resolution to be included in future release.</p>

Issue Description	Description
PFB-05906 - ACCT_FSDetail Data Validation does not include M_NonLabor for Cost Management clients [TFS 16884]	<p>Symptom: The ACCT_FSDetail Data Validation does not include M_NonLabor, which does not allow admins to code Accts storing non-labor assessment data for Cost Management.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
PFB-05988 - Cost Management Process Management [TFS 17923]	<p>Symptom: Administrators not able to view Process Management for Target Setting and Cost Management plan files. Subsystem Security is set to No Access for Process Management within the file group for Cost Management.</p> <p>Explanation: Field fix is available. Resolution to be included in future release.</p>
