- This product upgrade contains updated templates, calculation methods, driver files, and remediated defects.
- KHA delivered reports may be replaced. Any report that you saved under a different name or created new will remain untouched. Replaced reports are available in Document History, if needed.
- Any KHA delivered report that was moved to a new location will automatically move back to its original location.
- KHA product templates and calculation method libraries will be replaced.
- Product task panes will be replaced.
- Process definitions will not be replaced.
- Security roles and sub-systems will be reset to their configured settings. All user security exceptions you may have made will remain intact.
- Specific items configured as part your organization's implementation such as imports, exports, driver files, and process management files, will remain as is. Any required modifications to these areas are covered in the release notes, if required.

Asset Replacement Planning module

The Asset Replacement Planning module is a separate add-on utility to Axiom Capital Planning that allows you to easily manage and analyze the replacement or retirement of your organization's equipment and other assets.

NOTE: This module is not installed as part of the upgrade to 2018.4. Contact your Kaufman Hall Representative if you are interested in purchasing this module.

You can load your organization's existing assets and use the utility to rate values on each asset to help with the replacement process, and use it to report on your findings.

With this module, you can manage:

- Identification Track asset details such as the equipment type, manufacturer, model, quantity, etc.
- Purchase Information Record in-service dates, acquisition cost, net book value, etc.
- Equipment Life Track the age and expected life of the asset.
- Service History and Costs Input service events, total service cost, and average service cost.
- Clinical and Serviceability Assessments Configure and assign weights to assessment criteria.
- Budget Evaluate estimated budget amounts for current and future services costs.

The system uses a weighted scoring system based on the assessment criteria you configure to generate a replacement score to help you determine when to replace or retire equipment.

Improved plan file performance by batching queries

To help improve performance when opening plan files, the system now batches queries so that calls to the database can be made simultaneously. This allows queries not related to each other to run together, helping to speed up processing time.

PFB-06321 - Web Financial Statements report does not exclude items designated Exclude from NPV (TFS 213590	Symptom: The NPV and IRR for the Financial Statements does not take into account the new driver file setting that was introduced in 2017.2 to Exclude from NPV specifically designated CODE items. Resolution: Corrected in a previous release.
PFB-06567 - Picklist Yes or No problem in the CX Project Import utility [TFS 24396]	 Symptom: If you use Yes or No as picklist choices (Picklist01_01='No') and the Save selection is also set to Yes or No, then the formula chooses Picklist01Save. Resolution: Corrected by updating the corresponding formula.

PFB-06582 - Capital Transfers overwriting transfers upon breaching 999 transfers [TFS 24822]	Symptom: When capital projects exceed 999 transfers, the system overwrites the transfers. Resolution: Corrected by updating formulas in several templates.
PFB-06582 - Capital Transfers overwriting transfers upon breaching 999 transfers calc method fix [TFS 29841]	 Summary: The calc method is not correct for the Multiple Capital Transfer utility. Column AS is different in the utility than it is in the calc method and does not return the correct result. Resolution: Corrected by updating the calc method and multiple formulas in the utility.
PFB-06751 - Evaluator Scoring report not saving back [TFS 27007]	Symptom: The Evaluator Scoring report does not save back to the database. Resolution: Corrected by updating several formulas in the report.

Issue Description	Resolution
PFB-06837 - Missing PR work flow in web form version [TFS 27879]	Symptom: Purchase Request process definition does not display in the Process Manager window for the web form version.
	Resolution: Corrected by adjusting the process management to resolve errors in the process flow.
PFB-06898 - Different drop-downs for OP Ex vs Cap Ex for the GL accounts [TFS 28708]	Summary: The Purchase Request line item includes a drop- down for Capital or Operating. When a user selects Capital, only those CAPACCT accounts marked with Capital display. However, when a user selects Operating, both Capital and Operating CAPACCT accounts display.
	Resolution: Corrected by adding a missing filter in the drop- down tag for the GL account when a user selects Operating.
PFB-06899 - Wrong file group referenced in the Open or Create a new	Summary: When creating a new project, the web form points to the Next Year drivers instead of the Current Year drivers.
project [TFS 28709]	Resolution: Corrected by pointing to the selected file group instead of the CP_NextYear_Web alias.
PFB-06907 - Dimension Update Report FG error [TFS 28751]	Summary: When updating the Dimension Update Reports, CAPACCT tab, I added a line and selected "SAVE". The system displays an error message that cell L7 on the VENDOR tab was a problem.
	Resolution: Correcting the missing data in the CT_Templates table when the table is blank.
PFB-06938 - CapProjectMaster{FY} formatting error on data lookup [TFS	Summary: An error displays when a user opens any plan files with a numeric value in TextField02.
29710]	Resolution: Corrected by fixing the format issue on the TextField02 data lookup.

lssue	Resolution
PFB-07205 - WEB form not saving appropriately [TFS 31474]	Symptom: When a user includes tax in some of their Capital tab of the NonThreshold template and click Save, the system does not display a "Successful save" message. After checking the CPREQ table, the tax was not added into the OrigBudget amount. Only when "Processing Plan Files" did the OrigBudget calculate correctly. This works as a work around, but needs to be corrected urgently.
	Resolution: Corrected by updating the formula in row 131 of the Capital tab to allow taxes.

lssue Description	Resolution
CP Web AddOrRebuildCapitalRequest form always uses CP_NextYear drivers [TFS 31949]	Symptom: When creating a new plan file in CP_CurrentYear or CP_PriorYear the drivers default to CP_NextYear, instead of the alias associated with the FG.
	Resolution: Corrected by updating the formula in cell D22 to point to D17 instead of D18.
