### Product upgrade notes

**IMPORTANT:** Refer to the respective Release Notes of each Axiom Healthcare Suite product licensed by your organization for product-specific considerations before upgrading. You must apply the Axiom Software Platform 2017.3 upgrade before applying any 2017.3 product upgrades. The Axiom Software Platform upgrades are backwards compatible so you can upgrade different products at different times, but you must upgrade to the Axiom Software Platform 2017.3 before the first product upgrade.

When upgrading to the 2017.3 version of Axiom Healthcare Suite, keep in mind the following:

- Each product upgrade contains updated templates, calculation methods, driver files, and remediated defects.
- Suite-upgraded components are included in all product upgrades.
- KHA delivered reports may be replaced. Any report that you saved under a different name or created new will remain untouched. Replaced reports are available in Document History, if needed.
- Any KHA delivered report that was moved to a new location will automatically move back to its original location.
- KHA product templates and calculation method libraries will be replaced.
- Product task panes will be replaced.
- Process definitions will not be replaced.
- Security roles and sub-systems will be reset to its configured settings. All user security exceptions you may have made will remain intact.
- Specific items configured as part of your company or organization's implementation such as imports, exports, driver files, and process management files, will remain as is. Any required modifications to these areas are covered in the release notes, if required.

### New features summary

This section includes a summary of the new or updated features for this release:

#### Certain Axiom Healthcare Suite product-controlled assets are now read-only

The following items are now read-only if they are installed by a product package and if they are configured to be replaced on product installation:

- Table columns
- Reports Library documents
- Folders (except folders in file groups)

Read-only reports can still be copied to create new versions, if needed. For folders, the read-only designation means that the folder cannot be moved, deleted, or renamed. Users can still have read/write access to the folder for purposes of creating new reports in that folder.

#### Validated values folder in Dimension Maintenance Utility

For those columns that require you to enter validated values, a folder icon now displays next to the column. Double-click the folder to choose from the list of values, or manually update the cell directly, or you can copy and paste the value(s) from similar cells.

This change provides a more efficient means to make bulk additions or changes to any of the dimensions. You can now copy blocks of content from similar elements to the new elements versus selecting the attributes one at a time.

Axiom Rolling Forecasting	Upgrade if you are not in an active planning cycle. If you are in an active planning cycle, we recommend that you wait until it has concluded.
Axiom Financial Planning	Upgrade if you are not in an active planning cycle. If you are in an active planning cycle, we recommend that you wait until it has concluded.
Axiom Cost Management	Axiom Cost Management is not included in the 2017.3 Axiom Healthcare Suite release.
Axiom Capital Planning and Capital Tracking	Upgrade if you are not in an active planning cycle. If you are in an active planning cycle, we recommend that you wait until it has concluded. Upgrade Axiom Tracking at the same time as Axiom Capital Planning.
Axiom Cost Accounting	Contact your Kaufman Hall Implementation Consultant for a recommendation before scheduling an upgrade for this product, but you can upgrade the platform to receive the platform level gains.

	<b>Resolution:</b> Corrected by removing the validation from the Add_New_ Dimension tab for KHABgtCode.
