Issues fixed

The following table lists the resolutions for issues addressed in 2021.3, released on October 11, 2021:

Issue	Description
98668 - Total PSIs measure incorrect	Summary: The Total PSIs measure includes PSIs 21-27 in the count, despite those measures being inactive. Resolution: Inactive measures have been removed from the measure calculation to more accurately represent active PSIs.
110498 - Frequent Readmission Report export is not including the facility	Summary: The facility associated with the index visit of the readmission is not being included in the Excel export of the Frequent Readmission report. Resolution: Facility column is now included in the Excel export. Sorting and filtering can be done on this column.

Issue	Description																								
96712 - Excess Days measure not being calculated correctly	Summary: When calculating expected values for the Excess Days measure, all MS-DRGs, including the ungroupables, are being included. Since ungroupable DRGs aren't a homogenous group that should have one expected LOS value, this is causing unreliable counts. 110083 - PPE Report review level can be inappropriately finalized	Summary: Users are able to finalize the review level of a PPE Report even when a report has been rejected. Resolution: The workflow now pauses when a PPE Report is rejected and the review level cannot be finalized until the report is approved.																								
97462 - Clinical Case Summary not including all nursing units	Summary: Nursing units that are assigned more than one type are only being pulled into the Clinical Case Summary once instead of once for each type assigned to them. Resolution: Fixed the process so it now pulls in each nursing unit once for each type assigned to it.
