Issues fixed in 2023.4

The following table lists resolutions for issues addressed in 2023.4.

Issue	Description
Same named crosswalks are accepted in Database Management System (DMS) [17267]	Summary: Duplicated or created crosswalks with existing names could erroneously appear in the system. Crosswalks with the same names are not allowed because users cannot distinguish between them (for example, when selecting a crosswalk for File Transfer Protocol (FTP) folders). Resolution: Added a validation rule that is unique to crosswalk
	models.
Users can't name a report the same name as a "deleted" report [17294]	Summary: When users attempted to delete a PPE report that was used in the past, the report appeared to be deleted, but it was not, which caused confusion when users were unable to name reports because the name already existed in the system.
	Resolution: Updated the PpeReport name validation logic to only check name uniqueness among active reports.
