This document provides the list of changes to shared areas of the Axiom Healthcare Suite products, which includes:



What's new in version 2023.4

Welcome to Version 2023.4 of Axiom Financial Institutions Suite!

This release of Axiom Financial Institutions Suite includes the following new features and enhancements:

Profitability Report Mart enhancements

Added the following fields to the CustProf and ProdProf tables to support enhanced reporting flexibility in the Profitability Report Mart (italicized fields in CustProf have been flagged as Key fields):

ProdProf

RecCount

CustProf

NOTE: SourceTable was already a field in CustProf, but it has been updated to a key field.

RPPS Pricing Request redesign

Redesigned the Pricing Request and Scenario structure, which removed the Pricing Request data table page. The Pricing Request page is now a grouping of scenarios where you can easily navigate to your scenarios without clicking through into a Pricing Request. You can now add and compare scenarios directly from the Pricing Request page as well as create new pricing requests.



Drivers and transactions page: New sort and filter function

Added sorting and filtering to the CAP Surveys > Drivers and Transactions page. Use this function to sort and filter the list by Driver ID.

RPPS CFF calculations update: Exclude months with no data

Updated the Cash Flow Forecaster calculation engine in RPPS to be more precise when predicting future 12-month cash flows. When historical months have no data, they are now excluded from future 12month cash flow calculations.

Non-interest calculation method: Spread Method updates

Updated the Account Growth drivers so that you can select a default spread method other than the "Days" method. Added a SpreadMethods tab to the Account Growth drivers table, in which you input a default spread method for each budget account. If you do not select a default, the "Days" method remains the default option. You retain the ability to make changes directly in the plan file via the dropdown menu.

Non-interest Account Growth Rate: Calculation method updates

Added the ability to input a Balance Growth Rate Method for non-interest calculation methods to match the functionality for balance sheet calculation methods. Now, non-interest calculation methods (Axiom Annual Growth Rate and Axiom Annual Growth Rate With Manual Adjustment) have two input choices for Balance Growth Rate Method:

- Annual Growth Rate
- Remaining Base year then Annual Growth Rate

NOTE: Set these input variables from the plan file Acct Growth Drivers table.

New Map Income page

Added the ability to map fee and non-interest income to the InstrumentProfitabilityMapping table from the web via a new page in the Command Center. This functionality replicates the previous web-based thick client functionality.

Access this page using the following path:

Command Center > Customer Account Profitability > Map Income

▶ Budget calculation methods update: New Manual Adjustment method

Updated the Budget calculation methods (Non-Interest and Simple Interest) on the balance sheet to include a method of Manual Adjustment. You can now select Manual Adjustment as a planning method, which presents by-month entry cells in which you can type in an adjustment to the balance.

What to know before upgrading

IMPORTANT: You must apply the latest Axiom upgrade before applying any 2023.4 Axiom product upgrades. Axiom upgrades are backward compatible so you can upgrade different products at different times, but you must upgrade to Axiom 2023.3 before the first product upgrade. Refer to the **Axiom Release Notes** for consideration before upgrading.

When upgrading to the 2023.4 version of Axiom Financial Institutions Suite, note the following:

- You can replace Syntellis reports. Any report that you created or saved under a different name remains unchanged. Revised reports are available in Document History.
- Any Syntellis report that was moved to a new location is automatically returned to its original location.
- Syntellis product templates and calculation method libraries are replaced.
- Product task panes are replaced.
- Process definitions are not replaced.
- Driver files are replaced.
- Security roles and subsystems are reset to their configured settings. Your user security exceptions remain intact.
- Specific items that are configured as part of your company or organization's implementation such as imports, exports, driver files, and process management files, remain unchanged. Any required modifications to these areas are covered in the release notes.
- Shared tables might have any of the following changes:
 - Columns reordered
 - New columns added
 - Old columns removed (rare)
- If you copy and paste into or from Axiom tables, please review the column order of those tables after upgrading to assess the impact to your internal processes.
